

As we know, there are 11 WSIS Action Lines (AL) from C1 to C11.

AL C1: The role of governments and all stakeholders in the promotion of ICTs for development; and it is being facilitated by ECOSOC/UNRCs/ITU;

AfICTA: Establishment of AfICTA in 2012 noting the gap in Africa of Continental Private sector engagement in WSIS. AfICTA has thus been proactive as a concerned private sector led organization in WSIS, CSTD, ITU, IGF etc.





AL C2 is on *Information and communication infrastructure* being facilitated by ITU;

AfICTA: Members have been involved in building robust fibre rings around and within Africa up to the and first mile. They're also at the forefront of building and rolling out data centres, IXPs across Africa. They're at the forefront of investment in 5G roll-out and in other 4th Industrial Revolution (4IR) technologies.





AL C3: Access to information and knowledge being facilitated by ITU/UNESCO;

AfICTA: Unprecedented number of private players have invested in ICT enabled education across all levels (primary, secondary and at tertiary institutions) with e-Learning being common site thereby providing access to important information and knowledge. Challenge is the slow pace of recognition of these institutions by concerned authorities. AfICTA also established an Information Hub, https://aficta.africa/info-hub/ to provide country by country access to vital business information to investors.





AL C4: Capacity building (development) by UNDP/UNESCO/ITU;

AfICTA: Apart from interventions mentioned in AL C3 above, AfICTA through its quarterly webinars and annual Summits has been developing capacities for business and other stakeholders to further play their roles in the realization of our vision, mission and the attainment of our goals.





AL C5: Building confidence and security in the use of ICTs by UNCTAD;

AfICTA: Our active participation in the ICANN ecosystem has enabled us to remain focused on strengthening confidence, security and resiliency of the Internet. As a private sector concern in Africa, we use this opportunity to oppose any form of new moves to impose new Internet Protocols (IP) regimes on the world as it is being proposed for the 2022 ITU Plenipotentiary.





AL C5: Building confidence and security in the use of ICTs by UNCTAD;

AfICTA: ... Question is, why fix what is not broken? We urge our govts not to support any move that would disorient the TCP/IP based open Internet in which we have invested heavily and that has continued to foster innovation and create wealth for our people.





#### C7: ICT applications namely

 e-Government by UNDP/ITU, e-Business by WTO/UNCTAD/ITU/UPU, e-Learning by UNESCO/ITU/UNIDO, e-Health by WHO/ITU, e-Employment by ILO/ITU, e-Environment by WHO/WMO/UNEP/Habitat/ITU/ICAO, e-Agriculture by FAO/ITU, e-Science by UNESCO/ITU/UNCTAD,

AfICTA: We commend govts across Africa for their e-Government/digitization initiatives and a number of AfICTA members have been involved in diverse roll-outs.





C7: ICT applications ...

...We recommend that the momentum be sustained and in the process should avoid expensive and unsustainable solutions that would be discarded in the future.

Members solutions on e-Learning, e-Health, e-Employment, e-Agriculture etc have continued to transformed digital landscape across Africa.





C8: Cultural diversity and identity, linguistic diversity and local content by UNESCO

AfICTA: While we appreciate several government initiatives to promote local contents, the actual coordination of the implementation process is key to success. Innovative solutions through Artificial Intelligence are being locally developed to enhance Africa's cultural diversity and identity and linguistic diversity. With this development are Intellectual Property concerns. African governments need to help to protect indigineous IPs in this regard.





C9: Media by UNESCO

AfICTA: Members are involved in changing the face of the Media. We provide training for jounalists to use new media and also provide crucial information/tools for them to effectively play their roles. As we are all aware, we are now news makers but let's make the news constructively for peace to reign in our communities and avoid fakenews.





C10: Ethical dimension of the Information Society by UNESCO/ECOSOC

AfICTA: While the private sector believes in selfregulation and governance, we however call on governments to ensure through smart regulations that **no matter the level of advancement in AI, AI products must remain accountable to humans.** 





C11: International and regional cooperation by UNRCs/UNDP/ITU/UNESCO/ECOSOC.

AfICTA: We collaborate and cooperate with our counterparts outside Africa in Asia, Europe and in North America through the signing of joint statements on the need for WTO IT agreements to be sustained for free flow of Information across borders without taxation which otherwise could bring chaos to the already chaotic supply chain challenges around the world among others issues.





WSIS (20) targets:

We are also helping out seriously on the (20) WSIS Targets viz

- connecting all villages with ICTs and establish community access points but much depends on govt policies in this direction.
- connecting all secondary schools and primary schools with ICTs but much depends on govt policies in this direction.





WSIS targets:

- connecting all scientific and research centres with ICTs but much depends on govt policies in this direction.
- connecting all public libraries, museums, post offices and archives with ICTs ...
- connecting all health centres and hospitals with ICTs...
- connecting all central government departments and establish websites...





WSIS targets:

- adapting all primary and secondary school curricula to meet the challenges of the Information Society, taking into account national circumstances but much depends on govt policies in this direction...
- ensuring that all of the world's population have access to television and radio services...
- encouraging the development of content and to put in place technical conditions in order to facilitate the presence and use of all world languages on the Internet...





WSIS targets:

 ensuring that more than half the world's inhabitants have access to ICTs within their reach and make use of them. Thanks to cooperation, more than 50% of the world now have access to ICTs (Internet).





Much of the WSIS ALs and target are subsumed in the Sustainable Development Goals.

Based on this fact, we are concerned that many organizations in Africa responsible for SGDs and ICT development/regulation are not in sync with their implementation strategies. If this trend continues, we can expect that by 2030 Africa would have missed the realization of the SDGs.





A measure to know if indeed we are on the right tract is the availability of joint Annual National Reports of implementation Agencies to indicate progress on the SDGs for all to review and follow-up.





### Conclusion

The private sector in Africa is a partner in progress with government to creating wealth and taking our people out of poverty. We are partners towards the realization of the WSIS ALs and SDGs.

However, it is clear that if the government does not move to provide the enabling environment (AL C6) nothing would move. Therefore, the imperative of multi-stakeholder engagement in policy formulation and implementation cannot be over-emphasized on our road to SDGs 2030.





# Conclusion

AfICTA commends UNECA for her steadfast commitment and sustained engagement towards nurging all stakeholders in Africa particularly governments to stay the course towards the WSIS AL Implementation and the realization of the SDGs.
